

COOKIES POLICY OF LOTTE WEDEL WEBSITE

Dear User,

LOTTE Wedel Sp. z o.o., based in Warsaw, takes the issue of protecting your privacy and personal data as a priority. Your safety is very important to us.

Our Cookies Policy describes, as part of the service available at: www.wedel.pl (hereafter: **Website**), our use of “cookies” and similar technologies - hereinafter collectively referred to as Cookies. We encourage you to read this document.

I. INTRODUCTORY INFORMATION

The owner and operator of the Website is LOTTE Wedel Sp. z o.o. with its registered office in Warsaw, ul. Zamoyskiego 28/30, 03-801 Warsaw, entered in the Register of Entrepreneurs of the National Court Register, kept by the District Court for the Capital City of Warsaw XIII Commercial Division of the National Court Register under the number 0000340664, NIP 527-26-13-819, REGON: 142078650, share capital PLN 141,905,000.00 (hereinafter: **LOTTE Wedel** or **we**).

II. WHAT ARE COOKIES?

Cookies are small text files that are sent to the memory of the endpoint used by the User. They constitute IT data, stored in text files, which may contain personal data (e.g., in the form of IP address and unique identifier). These files and similarly functioning technologies allow to simplify or accelerate the operation of the Website, sometimes to completely avoid performing similar or the same actions repeatedly. Cookies are harmless to the User’s device and data. Cookies usually contain the name of the website from which they originate, the time they are stored on the endpoint and a unique number.

III. WEBSITE COOKIES

1. The Website does not collect information automatically, except for technical information (e.g., contained in logs) and information contained in Cookies.
2. There are two main types of Cookies used as part of the Website:
 - a) “Session”: temporary cookies, stored on a User’s endpoint until the User leaves the website or shuts down the software (web browser);
 - b) “Permanent” (also called “persistent”): stored on a User’s endpoint for the time specified in the parameters of Cookies or until they are deleted by the User.
3. In addition, the following types of Cookies are used within the Website:
 - a) “Essential” Cookies that enable the use of the services available on the Website, such as authentication Cookies or security-related Cookies, such as those used to detect authentication abuse on the Website;
 - b) “Performance” Cookies, enabling the collection of information about the use of the Website;
 - c) “Functional” Cookies that allow “remembering” the User’s selected settings and personalizing the User’s interface, e.g., with regard to the User’s selected language or region of origin, font size, website design, etc.;
 - d) “Advertising” Cookies, allowing to provide Users with advertising content better tailored to their interests.
4. The Website uses Cookies in order to:

- a) ensure the proper and safe operation of the Website for the User and his/her device;
 - b) assist Users in navigating the Website effectively and comfortably (adapting the Website to individual User settings and remembering the data entered by the User related to the use of the Website, such as the Website display language or the choice regarding the storage of Cookies);
 - c) ensure various functions, including monitoring and analyzing traffic, building statistics (conducting statistical analysis on Users visiting the Website, such as number of views and statistics on interest in particular elements of the Website), which are used to identify errors, solve issues concerning the Website and its functioning, help to understand how Website Users use the Website, which enables us to improve and further develop the Website and serves to improve the effectiveness of our marketing activities);
 - d) provide advertisements, including for marketing purposes, organizing advertising campaigns and promotions.
5. Cookies on the Website User's endpoint may also be used by advertisers and partners cooperating with us - collectively known as Trusted Partners.
 6. Detailed information about accepted Cookies, Trusted Partners and the storage period of Cookies can be found by the User at any time in the Cookies Settings available [here](#) and in the footer of the Website.

IV. MANAGING, VIEWING AND DELETING COOKIES

1. In many cases, web browsing software (web browser) allows cookies to be stored on User's endpoint by default.
2. Website Users may change their settings regarding Cookies at any time, in particular in such a way as to block the automatic Cookie storage and reading. Users may change their current settings and preferences regarding Cookies:
 - a) in web browser settings;
 - b) using the Cookies management panel available [here](#) and in the footer of the Website.
3. Detailed information about the possibility and methods of handling cookies is available in software (web browser) settings.
4. Website Users can access the Cookies stored on their device by analyzing the contents of their Internet browser's memory, using their Internet browser settings. The web browser settings also enable Website Users to delete Cookies stored on their devices at any time.
5. Please note that restrictions on the use of Cookies may affect some of the functionalities available on the Website, and in extreme cases may make it difficult or impossible to use the Website.
